## THE #GIVINGTUESDAY BED PROGRAM


We all know what a poor night's sleep feels like. All day, you're in a fog, you can't concentrate, and you wait for the moment that you can go home and sink back into the comfort of your own bed. For some of our neighbors in need, this isn't an option. For those without proper bedding, every night can feel like a poor night's sleep, which can lead to serious cognitive, physical and emotional consequences.

With that in mind, SVDPLI launched the Virtual Slumber Party on December 3rd, 2019, as part of our Giving Tuesday campaign. Throughout the day, we shared statistics and success stories about our bed donation program, including the fact that SVDPLI thrift stores donate more than \$122,000 worth of bedding to neighbors in need every year.

How fortunate we were to have such a tremendous response from our supporters and matching donors! In just 24 hours, the Society raised more than \$19,000 to benefit those without proper bedding on Long Island.

#### NEGOTIATING THE RELATIONSHIPS OF PARISH LIFE: A FORMATION EVENT

St. Vincent de Paul once said, "Forbearance (or patient self-control, restraint, and tolerance) is the bond of friendship that unites hearts in sentiments and action not only among themselves but in Our Lord, in such a way that they enjoy great peace."

It is with that same forbearance that we framed our discussion on the evening of October 29, 2019. At our formation event, The Three Cs: Negotiating the Relationships of Parish Life, we hoped to provide some insight into the relationships that affect the Conference on a regular basis—that with the Pastor, with each other, and with our fellow parishioners. When we are in right relationship with the Clergy, the Conference, and the Congregation, we can receive many gifts and rewards from each of these interactions. However, we know that sometimes, they are fraught with tension and frustration. Instead, we want to build trust and in our thoughts and words give people the benefit of the doubt. We should assume they are always well intentioned at heart.

We know that there is a continuum of experience with some of these challenges among our Conferences. Some resonated with the examples provided; others found them foreign. However, the audience approached the discussion with open minds and learned how to anticipate and address them should they occur. Msgr. Jerry Ringenback offered insight into the role of the Pastor and the many responsibilities the priest assumes when administering over the parish as well as ways to engage other parishioners in the Society. Central Council staff, Paula Migliore and Terri Zenobio, explored how fellowship is promoted in the Conference among differences of opinions, passion and zeal for the ministry, and genuine concern for our neighbors.

This program was specifically designed with the revitalization and sustainability of our Conferences in mind. Serving in Hope Module VI explains, "Effective Conferences show initiative". As Vincentians, we look to ways we can creatively improve our efforts in order to fulfill the goal of our founder, Bl. Frederic Ozanam, "to become better and do a little good". Fortunately, every member of the family was able to make it out alive and unharmed, but in a matter of minutes, their home was engulfed in flames. Lisa's fire was the top story on the evening news, and the community responded with a fury. Perhaps inspired by the Advent season, the family—now living in a hotel room-was flooded with restaurant gift cards, blankets and clothing from their neighbors in Mastic Beach. It was then that Lisa was first introduced to Michelle and Ron, two Vincentians from St. Jude Conference, who explained to her the mission of the Society of St. Vincent de Paul Long Island, and reminded Lisa that although her situation seemed dyer, she had a strong network of people in her community that were there to support her.

With help from the Department of Social Services in Suffolk County, Lisa's family was able to find an apartment in the new year. But as time moved on and the news of their family tragedy died down, Lisa felt the support of the community waning. While she was grateful to have a roof over her family's head, she struggled to replace all of the items that had been lost in the fire. Remembering her warm conversation with Michelle and Ron, Lisa called the Conference at St. Jude for help in early 2019.

that one can begin to emerge from the ashes. Lisa's story is a reminder about our Vincentians' true calling—to utilize the skills and talents with which they have been blessed in order to ease the suffering of our neighbors in need during their most trying times.
